Geen ketels, verwarmers of enige ander toerusting wat meer as 15amp gebruik, mag gebruik word nie. Maak seker dat alle elektriese toestelle saans afgeskakel is. Geen 3-fasekrag beskikbaar nie. Stalletjies sonder elektrisiteit is nie geregtig op elektrisiteit nie en kan dus nie elektrisiteit van iemand anders se stalletjie aanlê nie! No three phase electricity is available. Please note that if you applied for a stall without electricity we will not move you to a stall with electricity when you get to the festival, you will also not be allowed to draw electricity from someone else's stall.
